

• A Framework for Qualifications of the European Higher Education Area (2005, 23):

"Broadly speaking, one may identify four main purposes of higher education:

- preparation for the labour market;
- preparation for life as active citizens in a democratic society;
- personal development;
- the development and maintenance of a broad, advanced knowledge base" (German discourse: scientific capability)



I. What is higher education all about?

Rome Communique (2020, 6):

"We support our higher education institutions in intensifying their search for solutions to the challenges our societies face. The social, human and creative sciences and arts must continue to play their vital role, giving depth to our lives and enabling us to understand and act in a changing world. Our higher education institutions must engage with their communities to undertake mutually beneficial and socially responsible joint activities"




What is competence?

Weinert (2001a: 2433) defines "competence' as referring to combinations of those cognitive, motivational, moral, and social skills available to (or potentially learnable by) a person [...] that underlie the successful mastery through appropriate understanding and actions of a range of demands, tasks, problems, and goals"




What are Future Skills?



What are Future Skills?

Ehlers (2020, 23): "Future Skills are competences that allow individuals to solve complex problems in highly emergent contexts of action in a self-organised way and enable them to act (successfully). They are based on cognitive, motivational, volitional and social resources, are value-based and can be acquired in a learning process.



What are Future Skills?

Ehlers (2020, 3): "Promoting Future Skills[...] enables future citizens to[...] to care for greater coherence in society, to value openness, tolerance and an awareness of differences and diversity. [...] the question of [...] how we can strengthen justice, peace and the integrity of creation and community as values in a future society, will determine the relevance of our higher education Institutions in the future"









